By entering the **"Win a Jamberoo Summer Family Pass"** competition, you are agreeing to the following terms and conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

2.1 Entry is open to all Freddy's Skip Bins Pty. Ltd. ("Freddy's Skip Bins") customers who hire a skip bin between, **Tuesday 1st September 2020 - Thursday 1st October 2020**, and retain a valid Freddy's Skip Bins Tax Invoice.

3. HOW TO ENTER

3.1 The competition commences on **Tuesday 1st September 2020** and concludes on **Thursday 1st October 2020 at 11.59pm**.

3.2 In order to enter, eligible entrants must complete the competition entry form on the Freddy's Skip Bins website during the competition period. Eligible entrants must provide name, email address, street address (including postcode), telephone number and their paid Freddy's Skip Bins Invoice Number (Unpaid invoices will be classed as invalid entries).
